**Processing Services**

**Electronic Claims** – This transaction allows a Customer to submit Medial or Institutional claims in a standard electronic format in a batch basis through Relay Health’s system for transmission to payor.  
**Electronic Remittance** – This transaction allows a Customer to Receive an Electronic Explanation of a specific claim’s adjudication by payor, including payment information action on a specific claim. The file received electricity can then be posted to the transaction in your Medisoft software.  
**Electronic Eligibility Verification** - this transaction allows a Customer to submit a real-time online request for verification of patient’s eligibility status for insurance.  
**Paper Claims** – A claim received by RelayHealth from a Customer that cannot be sent electronically to a designated payor will be processed and printed on paper in a standard format. RelayHealth will mail the processed paper transaction to the payer address designated in the paper transaction. There will be a charge of \$0.55 per claim for all paper claims.
